3	Board Expectation		 You will sustain your independence and continue to fulfill the criteria specified under Section 149(6) of the Companies Act, 2013 for being considered independent during the entire tenure. You will abide by the Code for Independent Directors, specified in Schedule IV to the Companies Act, 2013. You will promptly file the declarations and / or confirmation required under the Company Law.
4	Committees	A CONTRACTOR OF THE CONTRACTOR	The Board of Directors may, if it deems fit, invite you for being appointed on one or more existing Committees of the Board or any such Committee that is set up in the future. Your appointment on such Committee(s) will be subject to the applicable rules and regulations.
